## Contest Details:

1. Age Categories include K - 2<sup>nd</sup> grades, 3<sup>rd</sup> – 5<sup>th</sup> grades, 6<sup>th</sup> - 8<sup>th</sup> grades
2. Registration Entry Fee: \$10
3. Waiver of Liability and Release signed by parent/guardian
4. Your Gingerbread House will be judged
5. A Photo of your Gingerbread House will be posted on social media along with your first name and grade.
6. Top Winners (first names) will be announced on social media and via email
7. Drop-Off/Judging Event will be December 11<sup>th</sup>, 2021.



## Gingerbread House Construction Guidelines:

1. Gingerbread House must be 100% edible (candy/embellishments) except for lights.
2. Non-edible support structure material other than the baseboard may not be used.
3. No artificial interior materials, such as Styrofoam or wood are to be used to construct or decorate the house.
4. All Gingerbread Houses must be placed on a plywood board base or cardboard not exceeding 24" x 24".
5. You may use a store-bought kit; however, creativity and originality will earn a higher score.

## Drop Off/Judging Day

1. Drop off your Gingerbread House on Saturday morning, December 11 at Location TBD.
2. Doors will open at 10AM.
3. Judging will begin at 11:00.
4. Top winners (1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> place) will leave Gingerbread House to be displayed on 3<sup>rd</sup> St.
5. Gingerbread Houses not selected for public display may take Home after judging in completed.

## Entries will be judged on: (maximum of 15 points)

1. Overall Appearance/Presentation: 1-5 points
2. Originality/Creativity: 1-5 points
3. Precision/Attention to Detail/Neatness: 1-5 points



**Prizes will be awarded for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place winners in each age category.**
